## Shotgun Range Rules

1. All actions must remain open and unloaded when moving about the facility, when changing stations and until ready to fire.
2. All firearms are to be pointed in a safe direction at all times. Semi-auto and pump guns are to be carried with open actions and muzzle up above your head. Break-action guns are to be carried open with empty chambers.
3. Eye and ear protection are required.
4. No sharing of guns.
5. Shooters, coaches and Range Safety Officers only, no spectators are allowed on the field.
6. Guns shall be mounted only at a designated shooting position.
7. No shot larger than 7-1/2 is allowed.
8. Maximum number of shells in the shotgun
  - One shell for standard Trap.
  - Two shells for Doubles Trap or Wobble Trap.
  - Two shells for Skeet but only one shell per target at station 8.
  - Two shells for 5 Stand or Sporting Clays.
9. All firearms shall be clear (unloaded with empty chambers) before leaving any shooting station or changing any station in Skeet or Trap.
10. Pick up all empty hulls only when the round is finished.
11. Before reloading any trap be sure to release spring tension and turn it off.
12. When reloading or adjusting any Trap machine **always** place an orange pylon in a clearly visible location on top of the trap house.

## Pistol Range Rules

The Prescott Trap and Skeet Club provides a 50-foot pistol range for use by our MEMBER ONLY pistol shooters. There shall be **NO GUESTS**.

1. All pistol shooters must check-in with the cashier prior to using the range.
2. The red flag shall be raised prior to the range going hot and shall be lowered by the last shooter leaving the range.
3. All target frames must be set up at the locations provided.
4. No firearms are to be handled up range when people are down range. Actions shall be open, and guns shall be empty before any person may go downrange.
5. Firearms can be brought from vehicles only if they are holstered or encased.
6. The pistol range is for casual shooting practice and target shooting. Only target frames provided by the Prescott Trap and Skeet Club with shooter-provided paper targets may be used. **METAL TARGETS OR TARGETS PLACED ON THE GROUND ARE PROHIBITED**
7. Only one person per open shooting station is permitted to engage in shooting on the pistol range at any time.
8. All rounds must impact the berm and must not strike below or above it.
9. There shall be no "quick-draw", "cowboy action" or "rapid fire" shooting.
10. Handguns to have barrels under 10 inches long and calibers 45 and under.
